

'TAX TIME CASHBACK' 2022 - Terms and Conditions

1. Information on how to participate in the Ensitech TIG Brush 'Tax Time Cashback' promotion, forms part of these Terms and Conditions. Claims that do not comply with these Conditions of Entry are ineligible. Internet access, a valid email account and an active Bank account are required to redeem Cashback claims. By redeeming a Cashback claim, Participants agree to be bound by these Terms and Conditions.
2. Authorised TIG Brush Dealers, Employees of the Promoter, the immediate families of the Promoter and TIG Brush Dealers, and the affiliated companies and agencies of the Promoter and TIG Brush Dealers and their respective Employees, are ineligible to claim a Cashback. The TIG Brush 'Tax Time Cashback' promotion is only open to Participants. "Participants" means residents of Australia and New Zealand (other than the excluded persons set out in this clause 2), who purchase a qualifying TIG Brush Product from a participating TIG Brush Dealer during the promotional period. "Product" refers to any TIG Brush Product model mentioned within clause 4. By participating in this promotion, the Dealer accepts the full Terms and Conditions, and agrees to provide the Promoter, upon request, details of any transaction to validate the TIG Brush Product sold. It is the individual TIG Brush Dealer principle's responsibility to ensure all their staff are fully aware and abide by these conditions.
3. The Promoter is Ensitech P/L.; A.B.N. No. 92 144 914 401 of 1/ 144 Old Bathurst Rd, Emu Plains, NSW, 2750, Australia. Any queries relating to submitting claims should be made in writing via email to: sales@ensitech.com.au.
4. To obtain a Cashback (in the amount specified below for each Product), the Participant must purchase during the promotional period, (as set out in clause 5 below) one of the following TIG Brush products and their corresponding Cashback amounts: TBX-440 Kits (for \$250 Cashback); TBX-550 Kits (for \$350 Cashback) and TBX-700 Kits (for \$550 Cashback). This Promotion is available while stocks last, within the period specified in clause 5 below. Claims will not be accepted on Products purchased prior to the promotion start date or after the promotion end date, specified in clause 5. No rain checks.
5. Entries into the Promotion are valid only for Products purchased and paid for in full in Australia or New Zealand from authorised and participating Pro or Elite TIG Brush Dealers between 1st of May 2022 and 30th of June 2022 (inclusive, final claims must be lodged by 11:59pm on the 31st of July 2022). Participant(s) will forfeit claims not made by this date.
6. To lodge a Cashback claim, the Participant must visit www.tigbrush.com/au and complete the official online Warranty Registration form, by entering their details, answering the associated questions and attaching a proof of purchase receipt from their TIG Brush Dealer. Failing to provide all required information and receipt will be deemed invalid. Claims must be submitted via the TIG Brush internet site only. Claim forms sent via Post or any other method will not be accepted.
7. Multiple claims are accepted. Each Product purchased can only be used once for redeeming the associated Cashback. Claims will be deemed invalid if the same serial number are used on more than one claim. Ensitech reserves the right to request that claimants present proof of purchase for Cashback claim validation.

8. The Cashback funds will be issued by EFT (Electronic Fund Transfer). Funds will be issued in Australian Dollars.
9. Please allow for up to 45 days from the date that the claim is validated for processing.
10. The Promoter reserves the right to extend the closing date of the promotion at their discretion.
11. With the exception of ordinary Product discounts, in the form of in-store sales offered by TIG Brush Dealers, the promotion is not valid in conjunction with any other promotional offer.
12. The Promoter's decision on all matters pertaining to this Promotion is final and binding and no correspondence will be entered into.
13. Claims are not transferable or assignable.
14. The Promoter shall not be liable for any loss or damage whatsoever which is suffered (including, without limitation, indirect or consequential loss), or for a personal injury suffered or sustained, as a result of participation in this promotion, except for any liability which cannot be excluded by law.
15. The Promoter will use the information contained in the claim form to contact Participants if it has any queries regarding claims, and to send fulfillment of Cashback claim.
16. The Promoter reserves the right to verify all entries. Entries are void if illegible, forged or tampered with in any way. No responsibility is accepted for late, lost or misdirected claims via the Internet.

The Promoter reserves the right, at its sole discretion to disqualify any claimant who the Promoter has reason to believe has breached any of these Terms and Conditions, or engaged in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the promotion. The Promoter reserves its rights to recover damages or other compensation from such an offender.

To the extent permitted by law, the Promoter and its agents exclude liability for any problems or technical malfunction of any telephone network or lines, computer on-line systems, servers, or providers, computer equipment, software, technical problems or traffic congestion on the Internet or any web site, or any unauthorised intervention, incorrect or insufficient supplied merchant identification parameters, or any combination thereof, including problems that prevents a Participant from obtaining a Cashback, or which cause injury or damage to the Participant's or any other person's computer related to, or resulting from, participation or attempted participation in this promotion.

If for any reason this Cashback redemption is not capable of running as planned including: infection by computer virus, bugs, tampering, requirement of a regulatory body, unauthorised intervention, fraud, technical failures, incorrect or insufficient supplied merchant identification parameters, or any other causes beyond the reasonable control of the Promoter which corrupt or affect the administration security, fairness integrity or proper

conduct of this redemption, the Promoter reserves the right in its sole discretion, to cancel, terminate, modify or suspend this promotion.

20. The Promoter collects personal information about Participants for the purpose of including Participants in the promotion. Unless otherwise notified by the Participant to the Promoter in writing, in providing their personal details, each Participant agrees to the Promoter using their details for future marketing and publicity purposes, to the extent permitted by the law, and to the Promoter disclosing such information to third parties for this purpose. If any information requested is not provided, the purchaser may not participate in this promotion.
